

Regular Meeting Minutes
Monday April 13th, 2026
6:30PM, City Hall

The regular meeting of the Donnellson City Council was called to order by Mayor Willis Krehbiel, with Council Members, Keefe, Marshall, Young & Wagner present. Dahms was absent. City staff were City Clerk Rebecca Schau, Librarian Sunny Robbins, Public Works Superintendent Todd Herdrich, Police Chief Roberts and Officer Jones. Others in attendance were Jane Duke, Nadine Allen, Janet Haeffner, Mariam Karaff, Sheriff Vandenberg, Deputy Juarez, Gary and Jody Ramatowski, Amber Roberts & Selissa Weber.

Motion by Young second by Marshall to approve the agenda: all ayes.

Resident expressed appreciation for the monthly newsletter that is being published by city hall.

Motion by Marshall, second by Young to approve the consent agenda: all ayes.

Motion by Marshall, second by Young to set May 2nd 2026 for Roadside Cleanup. Meeting at the fire station at 8:30am, all volunteers are welcome to come: all ayes.

Motion by Young, second by Keefe to approve removing \$100,000 from water CD to pay on GO Loan @ PGSB and then keeping the remainder of the funds in a CD for 11 months at an interest rate of 3.85%: all ayes.

Chief Roberts was recognized for his years of service to the Donnellson community and welcomed interm chief Jackson Jones.

Issues with Gworks Accounting Software were discussed. Clerk asked to be able to go to Farmington to look at their accounting software as an alternative.

Motion by Young, second by Marshall to approve a pay increase for Alisha Davidson to \$20 an hour effective April 13th 2026: Wagner, Marshall & Young Ayes, Keefe Nay.

Police Report – There were 44 calls for service with 4 being traffic stops. Chief updated council regarding nuisance property that had gone to court. Property owner was given 90 days to clean up junk or he will be assessed a \$6,500 fine. Water/Sewer Superintendent Report – discussion on replacing public works employee. Flushing of Mains will be starting April 20th.

City Clerk Report – several grants have been submitted for new playground equipment at Railroad Park. Also working with Little Tykes on other fundraising options.

Council member Young asked the council if any members would be willing to volunteer at the concession stand at the ball park this spring, they are to reach out to him if able.

There being no other business to come before the Council, motion by Young, second by Marshall, Mayor Krehbiel declared the meeting adjourned: all ayes.
